They have expressed willingness to share their problems in producing a business plan with us. I shall report more fully at the Meeting.

MINUTES OF THE MEETING OF THE COMMITTEE HELD ON 8TH MAY 1991 AT 7.30P.M. AT 10 SPRINGFIELD ROAD, STORNOWAY.

PRESENT: Revd Stanley Bennie (Chairman), Martin Hall, Angus Maciver, George N. Macleod, Andrew Larcombe, Calum Ferguson, and Irene Smith-Macleod.

APOLOGIES: Morag Ann Macleod, Colin Scott Mackenzie, Jon Hague and Alistair Nicholson.

The Chairman welcomed those present for the first time and gave a brief history of the work of the Group. He had received information from the Radio Authority detailing conditions and fees for applying for and operating an Independent Local Radio station; the fee tariff for FM is £4 per 1,000 adult population up to 100,000; the DTI fee is £246 for less than 100,000 adults perannum. The DTI also charged :£18 per talk-back channel £36 per audio link channel £72 per terrestrial

#### FINANCE.

To meet current expenses e.g. postage, stationary, phone calls, photocopying, it was agreed that members be invited to contribute a small amount for a "kitty". Morag Ann Macleod was applying for a grant from the new Leader Programme through Barry Edwards of the Council for a feasibility study on the grounds of social, cultural and economic issues as this is a diversification programme. It was noted that the Local Enterprise Company has a training budget.

It was generally felt that there was need for a plan or document to be produced as a handout so that people in the community would know what the Group is doing and giving the raison d'etre for Community Radio. It was felt that we would need to identify the needs of different groups in the community regarding programming and the possibility of market research was discussed.

ACTION.

Stanley Bennie: to write the text for the plan or document for public information.

Angus Maciver: to produce the document. Martin Hall and Andy Larcombe: to approach the RAF Station Meeting with a view to fund raising.

Calum Ferguson: to approach 'contacts' in the media world for advice and information. Morag Ann Macleod: to approach Barry Edwards at WIIC for funding for a feasibility study.

DATE OF NEXT MEETING. To be decided. The Meeting closed at 9.25p.m.

# What is the aim of the Group?

-to promote community radio within the catchment area of the town of Stornoway with a view to setting up and operating a local community radio station.

What is community radio?
-In the Broadcasting Act 1990
the Government set up the
Radio Authority to oversee independent local radio and to offer licences for small community radio stations to serve small
communities or special interest
groups. During 1990 applications were invited in Scotland
for stations in the Shetland Islands, Aberfeldy and Pitlochry,

Paisley, Inverurie, and Kirkcaldy and Glenrothes.

# When could a community radio station begin operating in Stornoway?

-That depends on when the Radio Authority decides to advertise for applications for a licence for this area. They will wish to see public support for a community radio station through an enthusiastic Group. So, get in touch and get involved!

#### Is there a need for a community radio station in Stornoway?

Many people have fond memories of the bi-lingual output of the former BBC Radio nan Eilean. The BBC's current excellent programming in Gaelic and English is, however, transmitted to the Highlands and islands or to the

whole of Scotland. A Stornoway community radio station could supplement existing rad provision with programmes of very local interest.

# What would be the coverage area?

-a low power VHF radio static is likely to be heard in the tow of Stornoway, Point and Back North Tolsta, covering a popution of approximately 15,000.

### Would there be Gaelic programmes?

-Yes; Community radio is intended to meet the needs of the community and Gaelic is important part of the local cuture. The Group would wish to complement, not compete withe output of BBC Radio nan Gaidheal by, for example, bilingual programmes, Gaelic to

tion programmes, and giving airtime to Gaelic groups who wish to submit programmes.

What is the target audience?
-All ages and special interest groups; the station will provide what the community wants.

# What hours would the station broadcast?

-initially for a limited period at breakfast and tea-time. Later, hours can be extended. At other times another station can be relayed as a sustaining service.

### What programmes are planned?

-Local interest items e.g.
"Harbour News", "Road News",
"School News", "On the Islands
this Week"; special interest
groups can produce pro-

grammes if they wish, e.g. Radio Ranol; clubs and societies.

### Who will run the radio station?

-initially, committed volunteers. If funds permit, it might be possible to employ a station manager/producer.

# How will it be financed? -by advertising, sponsorship, fund-raising, and subscriptions.
